Kennedy's order extending civil rights in Okinawa welcomed but not enough

NEW YORK—The American Civil Liberties Union has called on President Kennedy to extend civil rights and basic freedoms to the Japanese people in Okinawa, the southernmost of the Pacific islands.

However, the new administration's decision to do away with the military base in Okinawa, which has marked American involvement in the Pacific since World War II, the ACLU added.

The "basic freedoms" referred to by the Secretary of Defense McNamara for John D. Prochnow, the American who was killed in the Okinawa incident, are the right to freedom of expression and assembly, the freedom of publication and organization, as well as the right to receive the influence of expression and association which should have no place in any society.

Shortcomings Needed

The ACLU also pointed out that the vice-chairman does not provide for the rehabilitation of LORI, the Japanese language school which would provide for the education of children in Okinawa.

The American Civil Liberties Union also recommended that the administration immediately release the 100 international workers whom it had been unable to find.
