Hawaii still leads the nation in tuberculosis, but continues to show a decline in the pre-valence of the disease, ac-cording to the Center for Dis-ease Control. Statistics show that Hawaii had 30.4 cases per 100.000 during 1973. Alaska and Tennessee followed in that order. The national mean for 1973 was reported at 14.8 cases per 100,000.
